Alumni Access Card Agreement and Release

You have requested that Johnson & Wales University (the "University") issue you an access card to allow you to access to certain University owned or leased property ("University Property"). In consideration of the University's providing an access card (an "Access Card") to you, you agree as follows:

1. You will comply with all applicable laws and all University policies and rules while on any University Property.
2. The University has the right to monitor the activities of users of University provided access cards at any time and for any reason. You agree to that monitoring.
3. The University may revoke your access privileges to University Property and terminate your Access Card at any time and for any reason.
4. You will not loan your Access Card to anyone and you will be responsible at all times for all use of the Access Card.
5. You will report promptly any theft or loss of your Access Card to University Safety & Security at (980) 598-1900.
6. Your right to enter upon and access the University Property is at your sole risk and expense. You hereby release, on behalf of yourself and your heirs and personal representatives, and agree to indemnify and hold the University and each of its trustees, employees, or agents harmless from any and all responsibility or liability for any injury, death, damage, loss, cost, or expense, in any way arising out of or resulting from your entrance upon, access to, or activities conducted on or about University Property.
7. If any damage to University Property is caused by your entrance upon, access to, or activities conducted on or about University Property, you will liable for that damage.
8. You agree that you will not conduct any business activities on University Property or using University resources without prior written authorization from the University.

FITNESS CENTER AGREEMENT**

Rules of Use

1. You agree that if you do not have your official Johnson & Wales University I.D., you will not be allowed to use the Fitness Center.
2. You agree that you will not take any bags, sweatshirts, fleece jackets, or any other article of clothing into the Fitness Center and place them on the floor or any piece of equipment. You agree not to store anything within the Fitness Center.
3. You agree not to wear sandals, any open toed shoes, any type of boots, or blue jeans in the Fitness Center. Participants who want to use the Fitness Center must wear proper gym attire. You agree to wear only rubber soled athletic shoes with non-marking outsoles on the court surfaces. No cleats of any type are permitted.
4. You agree that no vulgarity or derogatory language is tolerated in the Fitness Center.
5. You agree not to drop weights or dumbbells while in the Fitness Center.
6. You agree to not willfully misuse or destroy any Fitness Center equipment.
7. You agree to return all weights to the proper places when you are finished using them. You agree not to leave weights lying around, and that you will pick up after yourself.
8. You agree to provide your own lock for use at the Fitness Center. Locks are for sale at the front desk. The Fitness Center does not provide locks.
9. You agree that Johnson & Wales University, including all University employees, are not responsible for personal items, including but not limited to keys and jewelry that you bring to the Fitness Center, including items that are held at the front desk.
10. You agree that use of the Fitness Center is a privilege, and Johnson & Wales University reserves the right to revoke this privilege at any time in its sole discretion, including, without limitation, your failure to abide by these *Rules of Use*.

Medical Examination

You acknowledge that use of the Fitness Center may have harmful effects. You agree that you are solely responsible for your use of the Fitness Center. It is strongly recommended that all participants undergo a physical examination prior to using the Fitness Center, and carry some form of health and injury insurance. You agree that it is your responsibility to consult with a physician prior to using the Fitness Center.

**** ASSUMPTION OF RISK AND RELEASE ****

Use of the Fitness Center is on a voluntary basis. You agree to assume the risks normally associated with use of the Fitness Center. You acknowledge that Johnson & Wales University is not responsible for your ill health or injury sustained while using the Fitness Center. You acknowledge that Johnson & Wales University shall not pay any medical and/or ambulance expenses incurred by you.

You acknowledge that you have read this Fitness Center Agreement carefully and understand its contents. Knowing the risks involved and in consideration of being permitted to use the Fitness Center at Johnson & Wales University, you agree, on behalf of yourself, your family, heirs, and personal representative(s), to assume all the risks and responsibilities arising from your use of the Fitness Center. To the maximum extent permitted by law, you release and indemnify Johnson & Wales University and its officers, trustees, employees, and agents from and against any present or future claim, loss, or liability for injury to person (including death) or property which you may suffer or for which you may be liable to any other person or entity, arising in connection with your use of the Fitness Center.
